












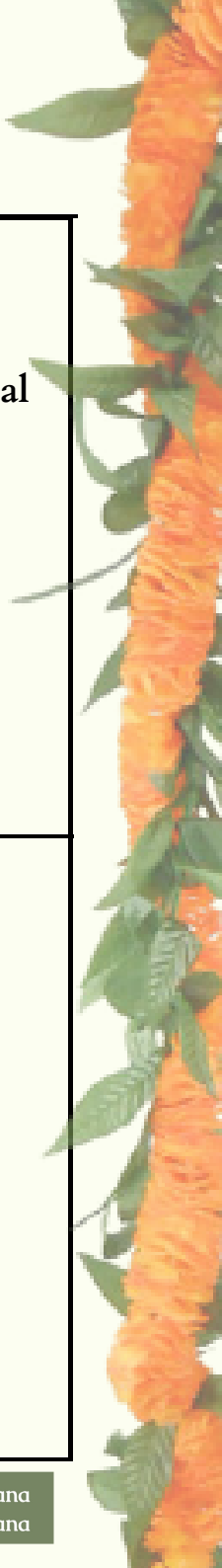

Construction work must be completed. The property must have been already approved for a Vacant Agricultural Land Dedication. <p>Home Exemption Continuance Relocation to Care Home or Facility Annual DEADLINE: September 30th</p> <p>BFS-RP-P-3A</p> <p> <u>Application Form HERE!</u></p>	<p>Home Exemption Continuance Change in Status Notice of Temporary Relocation DEADLINE: *24 months (2 years) before reoccupancy of home</p> <p>Claim for relocation due to Home Renovation, Sabbatical or Temporary Work Assignment, and/or Fire Damage.</p> <p>BFS-RP-P-3B1</p> <p> <u>Application Form HERE!</u></p>	<p>Home Exemption Reoccupation from Temporary Relocation DEADLINE: *24 months (2 years) before reoccupancy of home</p> <p>BFS-RP-P-3B2</p> <p> <u>Application Form HERE!</u></p>

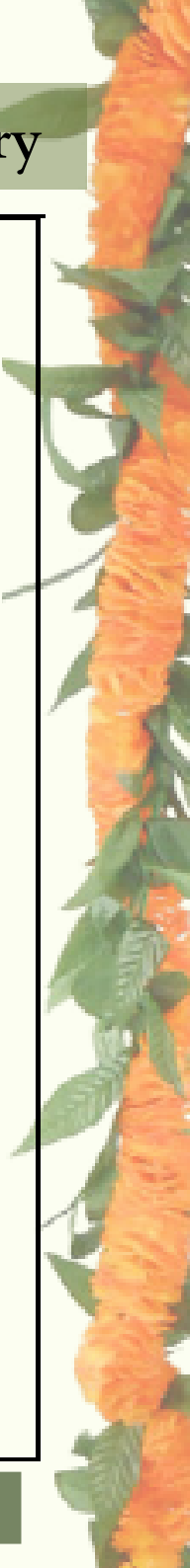
