<p>Request for Resident Income Tax Return Waiver</p> <p>DEADLINE: December 31st</p> <p>Request form for resident income tax return waiver.</p> <p>RP Form 19-71(e)(1)(D)</p> <p> <u>Application Form HERE!</u></p>	<p>Public Utilities Exemption Claim</p> <p>DEADLINE: December 31st</p> <p>Claim for exemption by Public Utilities.</p> <p>RP Form 19-89</p> <p> <u>Application Form HERE!</u></p>	<p>Charitable & Miscellaneous Exemption Claim</p> <p>DEADLINE: December 31st</p> <p>Claim for Charitable & Miscellaneous use. Veterans Exemption

DEADLINE: December 31st to make effective for the upcoming tax year or June 30th to be effective for the 2nd half of the tax year

Claim for Exemption as Totally Disabled Veteran.

DEADLINE: June 30 preceding the tax year for the first half payment or December 31 for the second half payment

Exemption Claim for the Totally Disabled, Hansen's Disease, Blind & Deaf persons.

DEADLINE: June 30 preceding the tax year for the first half payment or December 31 for the second half payment
